Wyandotte Nation Tribal Citizens enrolled in Pre-K through 12th grade (ages 3-18)



*****SEPARATE RECEIPTS FOR EACH CHILD*****

ORIGINAL APPLICATIONS AND RECEIPTS ONLY----FAXED, EMAILED OR COPIES WILL NOT BE ACCEPTED

Reminder: Allowable purchases include school supplies, backpack, lunch box and school clothing/shoes only. NO food, swim wear or accessories may be purchased or reimbursed through this program. For example: hair accessories, hair care products, jewelry, perfume, make-up, etc. will not be eligible purchases. If you have any questions as to what are eligible or ineligible items, please call our Family Services office.

Gift Card Program: Only eligible to Tribal Citizens residing in Oklahoma, Kansas, Missouri or Arkansas. It is mandatory to return the original school supply receipts from the Walmart cards given to you, by **September 30, 2021**. We have provided a return envelope for your convenience. Receipts from other stores will not be accepted. If receipts are not returned, you will not be allowed to use any program that utilizes the Walmart Gift Card. However, you will be able to use the Reimbursement Program. *Please write the name of the child on each receipt to ensure we give you proper credit and complete all application questions including roll #'s. Incomplete applications may not be processed.

Reimbursement Program: Eligible to Tribal Citizens nation-wide. Please use a separate application and separate receipts for each child. No combining children on same receipts. Complete all application questions including roll #'s. Incomplete applications may not be processed. Only original receipts, dated July 1, 2021 – September 30, 2021, will be accepted. All receipts and applications **MUST** be received in office or post-marked by **September 30, 2021 no exceptions**. Please remember to write the child's name next to each item on each receipt, indicating item purchased.



STORE RECEIPTS: Receipt must show what was purchased, date it was purchased and be legible. Please **DO NOT HIGHLIGHT OR USE TAPE ON RECEIPTS!** Please send full receipt. Don't send smudged or tiny receipts that we can't see. Check before you send. If we can't see it we can't count it. Remember...Separate Receipt for Each Child! No combining children on same receipt.

ON-LINE RECEIPTS: Only send full receipt/full email. No screen shots or partial receipts. They must show purchase date, individual item price, subtotal, tax and payment information. No order summary or shipment summary. Look for the details! Remember... Separate Receipt for Each Child!

This program is available for Wyandotte Nation, enrolled Tribal members age 3 to 18 years and enrolled in school/qualified learning program from Pre-K through 12th grade, residing in the states of Oklahoma, Missouri, Kansas and Arkansas. Each child is allowed, up to \$100, to purchase **school supplies, backpack, lunch box and school clothing/shoes only**. No food or other accessories such as hair accessories, hair care products, jewelry or makeup, can be purchased or reimbursed, through this program. See School Supply letter for further guidelines. *PLEASE NOTE:* Incomplete applications may not be processed. You will need your roll numbers.

GIFT CARD PROGRAM: ORIGINAL APPLICATIONS & RECEIPTS ARE REQUIRED:

I understand that I am to provide proof of purchase for each child, and that all receipts and applications are due in office, or post marked, by **September 30, 2021**. **Failure to provide proof of purchase receipts will automatically be cause for denial of school supply and winter clothing vouchers in the future.**

** Gift Card must be spent in full. If balance remains on card, card MUST be returned to Family Services.*
