<u>INSTRUCTIONS</u> PETITION FOR NAME CHANGE OF ADULT IMPORTANT INFORMATION-PLEASE READ!

- Petition for Name Change of Adult must be filled out completely to the best of your knowledge and ability.
- 2. Petition for Name Change of Adult must be signed in front of the Court Clerk or a Notary Public when you are ready to file.
- 3. Filing fees, copy fees, etc., must be made in the form of CASH, CASHIER'S CHECK, MONEY ORDER, DEBIT/CREDIT CARD OR E-CHECK (there is a processing fee when using a debit/credit card or e-check) and must be payable to "Wyandotte Nation Courts". Filing fees MUST be paid at the time of filing your Petition. If you are unsure of the amount of filing fees, contact the Court Clerk.
- 4. Submit original Petition for Name Change of Adult and one (1) copy of the Petition, if you would like a copy for your records. If the Court Clerk makes any copies, you will be charged \$1.00 for the first page and \$.50 for each additional page.
- 5. Court Clerk will issue Notice by Publication with date of hearing. You will take Notice of Publication to the Newspaper to be published and bring back proof of publication, once it has ran in the paper, to be filed with the Court Clerk.
