The Court Clerk is prohibited and CANNOT provide legal advice and wording on court documents as mandated by Ethical Code and Court Rules. The Court Clerk provides guidance to ensure your case successfully flows through the Court system.

## **INSTRUCTIONS** SMALL CLAIMS-FORCIBLE ENTRY & DETAINER IMPORTANT INFORMATION-PLEASE READ!

- 1. Small Claims Forcible Entry and Detainer Affidavit must be filled out completely to the best of your knowledge and ability.
- 2. The Plaintiff is the party or entity filing the Forcible Entry and Detainer Affidavit. The Defendant is the party that is being sued.
- 3. We must have a last known address for the Defendant to attempt service. If service cannot be made at that address, it will be your responsibility to provide to the court a new address for service.
- 4. Small Claims Forcible Entry and Detainer Affidavit must be signed in front of the Court Clerk or a Notary Public when you are ready to file.
- 5. Filing fees, copy fees, etc., must be made in the form of CASH, CASHIER'S CHECK, MONEY ORDER, DEBIT/CREDIT CARD OR E-CHECK (there is a processing fee when using a debit/credit card or e-check) and must be payable to "Wyandotte Nation Courts". Filing fees MUST be paid at the time of filing your Forcible Entry and Detainer Affidavit. If you are unsure of the amount of filing fees, contact the Court Clerk.
- 6. Submit original Small Claims Forcible Entry and Detainer Affidavit and one (1) copy of the Forcible Entry and Detainer Affidavit, if you would like a copy for your records. If the Court Clerk makes any copies, you will be charged \$1.00 for the first page and \$.50 for each additional page.
- The Court Clerk will fill out a SUMMONS with a DATE OF HEARING. The Forcible Entry and Detainer Affidavit and Summons will be served on the Defendant at last known address by Tribal PD, Process Server, or Certified Mail. Please let the Court Clerk know your preferred service method.
