### **INSTRUCTIONS** PETITION FOR NAME CHANGE OF MINOR CHILD IMPORTANT INFORMATION-PLEASE READ!

- 1. Petition for Name Change of Minor Child must be filled out completely to the best of your knowledge and ability.
- 2. Petition for Name Change of Minor Child must be signed in front of the Court Clerk or a Notary Public when you are ready to file.
- 3. Filing fees, copy fees, etc., must be made in the form of CASH, CASHIER'S CHECK, MONEY ORDER, DEBIT/CREDIT CARD OR E-CHECK (there is a processing fee when using a debit/credit card or e-check) and must be payable to "Wyandotte Nation Courts". Filing fees MUST be paid at the time of filing your Petition. If you are unsure of the amount of filing fees, contact the Court Clerk.
- 4. Submit original Petition for Name Change of Minor Child and one (1) copy of the Petition for the non-petitioning parent, if the non-petitioning parent did not submit the Entry of Appearance and Waiver, and one (1) copy for you, if you would like a copy for your records. If the Court Clerk makes any copies, you will be charged \$1.00 for the first page and \$.50 for each additional page.
- 5. The non-petitioning parent has to be noticed by either signing an Entry of Appearance and Waiver or served a Summons that the Court Clerk will issue with the date of the hearing.
- 6. Court Clerk will issue Notice by Publication with date of hearing. You will take Notice of Publication to the Newspaper to be published and bring back proof of publication, once it has ran in the paper, to be filed with the Court Clerk.
