Wyandotte Nation Tax Commission Required Supporting Documentation Repossession Affidavit

FEE: \$15

The reposessing lender must provide the following documentation in order for the Repossession Application to be approved:

- 1. Properly complete Repossession Affidavit**
- 2. Actual or certified copy of chattel mortgage, conditional sales contract or other type security agreement.**
- 3. Contract must indicate the vehicle has been pledged as collateral and list a complete description of the unit along with a vehicle identification number.**
- 4. Copy of #3 and #4 of the Lien Release Form. If more than one (1) lien holder, the following is also required:**
 - a. A copy of a certified letter from the repossession lender notifying the second lien holder of the intent to repossess.**
 - b. Letter must be dated at least ten (10) days prior to the date of the Commission Motor Vehicle Division.**
 - c. The post office receipt or the return receipt (green card) signed by the second lien holder is required as proof of mailing.**
 - d. If the second lien holder is making application for a repossession title, Copy #3 and Copy #4 of the lien releases from the first lien holder are required.**
