# Wyandotte Nation Tax Commission Required Supporting <u>Documentation Repossession Affidavit</u>

**FEE: \$15** 

The repossessing lender must provide the following documentation in order for the Repossession Application to be approved:

- 1. Properly complete Repossession Affidavit
- 2. Actual or certified copy of chattel mortgage, conditional sales contract or other type security agreement.
- Contract must indicate the vehicle has been pledged as collateral and list a complete description of the unit along with a vehicle identification number.
- 4. Copy of #3 and #4 of the Lien Release Form. If more thatn one (1) lien holder, the following is also required:
  - a. A copy of a certified letter from the repossession lender notifying the second lien holder of the intent to repossess.
  - b. Letter must be dated at least ten (10) days prior to the date of the Commission Motor Vehicle Division.
  - c. The post office receipt or the return receipt (green card) signed by the second lien holder is required as proof of mailing.
  - d. If the second lien holder is making application for a repossession title, Copy #3 and Copy #4 of the lien releases from the first lien holder are required.
